

**ORDINANCE 2023 - 07**

**AN ORDINANCE AMENDING ORDINANCE 2022-23 OF THE COMMON COUNCIL OF THE CITY OF HOBART, LAKE COUNTY, INDIANA, ADDING A POSITION TO THE WASTEWATER AND STORMWATER DEPARTMENTS**

WHEREAS, the Common Council ("Council") of the City of Hobart, Lake County, Indiana adopted Ordinance 2022-23 fixing the salaries of officers and employees of the City of Hobart for Fiscal Year 2023 on September 7, 2022; and

WHEREAS, the Hobart City Engineer has the duty to oversee the wastewater and stormwater operations in addition to his regular duties as City Engineer; and

WHEREAS, the City Engineer has now determined that there is a need to reorganize and expand the position of HSD Secretary to include additional duties and should more appropriately be titled: Assistant to the Engineer/HSD Secretary, a full-time, salaried position to be paid one-half (½) each from the Wastewater and Stormwater funds; and

WHEREAS, the Wastewater and Stormwater budgets each have positions of a clerical and project management nature that will now be included in the duties of the proposed newly created position with no additional funding to be requested; and

WHEREAS, the Council, having been advised of this request by the City Engineer, now desires to amend Ordinance 2022-23 regarding the Wastewater and Stormwater positions and compensation, adding a newly created position titled: Assistant to the Engineer/HSD Secretary along with an appropriate compensation;

**NOW THEREFORE, BE IT ORDAINED** by the Common Council of the City of Hobart, Lake County, Indiana as follows:

SECTION ONE: That Ordinance 2022-23, Section 1, Wastewater and Stormwater Department be amended by adding "Assistant to the Engineer/HSD Secretary" and the related compensation as follows:



Assistant to the Engineer/HSD Secretary	SW #6501	\$ 20,000	\$ 22,500

SECTION TWO: This Ordinance shall be retroactive beginning April 1, 2023 after its passage by the Common Council and approval by the Mayor.

SECTION THREE: All other provisions of Ordinance 2022-23 and any amendments thereto shall remain in full force and effect.






