

**COMMON COUNCIL OF THE CITY OF HOBART, INDIANA
Ordinance No. 2024- 01**

**An Ordinance Repealing the Fee Amount Ordinance No. 2013-39 § 4 to Reflect Amended
Fee Amounts Referenced in the Newly Enacted Ordinance No. 2023-27 and Contained in
the Hobart Municipal Code**

WHEREAS, the Common Council (“Council”) of the City of Hobart, Indiana (“City”) has been advised that recent changes to the Hobart Municipal Code (“Code”) regarding excavation fees in **Chapter 94: Streets and Sidewalks § 94.22** conflict with existing fees referenced in in **Chapter 150: Building Regulations: Construction § 150.093**; and

WHEREAS, in order to correct the inconsistency regarding the said fees in the above-referenced Code Sections, the City desires to repeal **§ 150.093** contained in **Chapter 150: Building Regulations: Constructions** in its entirety to correct the differing amounts cited for excavating fees.

THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart as follows:

SECTION ONE: The Municipal Code of the City of Hobart (“Code”), in CHAPTER 150, entitled “Building Regulations; Construction” is hereby amended, in the sub-chapter entitled **Excavations** by striking out and repealing in its entirety the language in §150.093:


~~§ 150.093 PERMIT; APPLICATION; FEE.~~

~~No such permit shall be issued unless and until the applicant therefor has deposited with the Clerk-Treasurer the sum of \$52.00 for each parcel of property to be excavated, which sum is to be made payable to the City of Hobart.


SECTION TWO: This ordinance shall become effective upon its adoption in the manner required by law, and upon publication thereof pursuant to I.C. §36- 3-4-6-14(b) in two newspapers of general circulation published within the City pursuant to I.C. §5-3-1-4 (a).

SECTION THREE: All ordinances or portions thereof in effect prior to the effective date and in conflict with the provisions of this ordinance are hereby repealed.




