

ORDINANCE 2024 - 14

AN ORDINANCE AMENDING ORDINANCE 2023-14 (as amended) OF THE COMMON COUNCIL OF THE CITY OF HOBART, LAKE COUNTY, INDIANA, TO ESTABLISH NEW POSITIONS AND FIXING THE SALARY FOR SUCH POSITIONS FOR THE FISCAL YEAR COMMENCING JANUARY 1, 2024 AND ENDING DECEMBER 31, 2024

WHEREAS, the Common Council of the City of Hobart, Lake County, Indiana adopted Ordinance 2023-14 (as amended) fixing the salaries of officers and employees of the City of Hobart for Fiscal Year 2024; and

WHEREAS, the Mayor and the Building Official have found a need to reorganize the Building/Planning Departments and to create a position in the Building Department of Office Manager to oversee the day-to-day operations of the department, and to create the position of Urban Planner & Sustainability Director, with duties to include MS4 compliance and GIS utilization; and

WHEREAS, are sufficient funds within the Building Department and Planning Department's current 2024 budgets to facilitate this organizational shift;

NOW THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart, Lake County, Indiana as follows:

SECTION ONE: That Ordinance 2023-14 (as amended) be amended to add the following position, line item and rate of pay in the Building Department's budget:


SECTION TWO: That Ordinance 2023-14 (as amended) be amended to add the following position, line item and rate of pay in the Planning Department's budget:

SECTION THREE: This Ordinance shall be in full force and effect after its passage by the Common Council and approval by the Mayor.

SECTION FOUR: All other provisions of Ordinance 2023-14 (as amended) shall remain in full force and effect.




