

COMMON COUNCIL OF THE CITY OF HOBART, INDIANA

ORDINANCE NO. 2025 – 16

An Ordinance Amending Ordinance 2025-04 and the Municipal Code of the City of Hobart to Amend Animal Licensing Fees and Charges

WHEREAS, the Common Council (“Council”) of the City of Hobart (“City”) has been advised that some of the fees and charges previously established under Ordinance 2025-04 and contained in the Municipal Code of the City for Animal Licensing are not conducive to the permitting process of the Animal Control Authority; and

WHEREAS, the Common Council recently adopted Ordinance 2024-40, shifting the issuance of animal licensing to the Animal Control Authority and Ordinance 2025-04 Establishing Animal Licensing Fees and Charges; and

WHEREAS, the Animal Control Authority has recommended to the Council a new fee schedule for pet licensing to allow for the processing of pet licenses with no reduced rate for additional canines and/or felines within the household; and

WHEREAS, the Common Council now desires to amend the fees adopted in Ordinance 2025-04 as recommended by the Animal Control Authority;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart, Indiana as follows:

SECTION ONE. The Fee Schedule for the City of Hobart is hereby amended by replacing the Cat, Dogs, Animal Licensing Annual fees with the following:

- Canine License: \$10.00 Additional Canine in Household: \$6.00
Feline: \$6.00 Additional Feline in Household: \$3.00
Senior Citizen (65+) and Veteran License Fee for Canine: \$5.00
Senior Citizen (65+) and Veteran License Fee for Feline: \$3.00
Hobart Resident with Service Animal for Disabilities: Fee Waived

SECTION TWO: This ordinance and the fees it sets out shall become effective as soon as it is adopted by the Council and signed by the Mayor of the City of Hobart.

SECTION THREE: All other ordinances or portions thereof in effect prior to the effective date and in conflict with the provisions of this ordinance are hereby repealed.


