

**CITY OF HOBART COMMON COUNCIL**

**ORDINANCE NO. 2025 - 25**

**AN ORDINANCE OF THE COMMON COUNCIL OF THE  
CITY OF HOBART, INDIANA, APPROVING BONDS  
OF THE CITY OF HOBART PARK DISTRICT**

WHEREAS, the Park and Recreation Board (the “Board”) of the Park District (the “District”) of the City of Hobart, Indiana (the “City”) has determined to issue special taxing district bonds of the District, in one or more series, in an aggregate principal amount not to exceed \$6,600,000 (the “Bonds”), to finance a portion of the costs of the design, construction or reconstruction, installation, acquisition and/or equipping of (1) an interactive aquatic spray pad water feature, (2) a paved parking lot, (3) plumbing, sewer and stormwater infrastructure, (4) new sidewalks, (5) a digital sign, (6) a dumpster enclosure, (7) decorative electrical pedestals, (8) a rentable public shelter, (9) a large destination playground, (10) an amphitheater pavilion with stage and full electrical system, (11) shoreline stabilization, (12) paved areas to accommodate stage and vendor access, (13) installation of electrical system updates, and (14) related facilities and improvements including parking facilities, pathways, landscaping improvements and amenities, site utilities, and site lighting and electrical, all for use by the City and its residents (collectively, the “Project”); and

WHEREAS, IC 36-10-3-25(c) requires the approval of the issuance of the Bonds by the City fiscal body before bonds of the District may be sold; and

WHEREAS, the Common Council of the City (the “Council”), as the fiscal body of the City, now desires to approve the issuance of the Bonds.


NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart, Indiana, as follows:

**SECTION 1.** Approval of Bonds. The sale and issuance of the Bonds of the District, in one or more series, in an aggregate principal amount not to exceed \$6,600,000 for the purpose of financing a portion of the costs of the Project, are hereby approved by the Council.


**SECTION 2.** Effective Date. This Ordinance shall be in full force and effect immediately upon adoption.






