ORDINANCE 2013-34

**AN ORDINANCE TRANSFERRING APPROPRIATIONS WITHIN THE
2013 BUDGET OF THE GENERAL FUND FOR VARIOUS DEPARTMENTS
TO COVER LONGEVITY EXPENSES
IN THE CITY OF HOBART, LAKE COUNTY, INDIANA.**

WHEREAS, it has been determined it is now necessary to appropriate more money than was appropriated in the annual budget in certain line items in the General Fund, various departments to cover longevity expenses in the 2013 budget; and

WHEREAS, it has been shown that there was an appropriation in the General Fund, Board of Works Department to cover the longevity expenses which were anticipated to be over what the individual department budgets originally had budgeted for longevity due to a Council determined increase in the longevity benefit for employees and transfers are now needed to meet the obligations of the various departments with regard to longevity through the end of the 2013 fiscal year,

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart, Lake County Indiana that:

Section 1(a). For the expenses of the taxing unit, the following additional sums of money are hereby appropriated out of the **General Fund: various departments as listed**, for the purposes specified, subject to the laws governing the same:






