**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF HOBART,
INDIANA, AMENDING ORDINANCE 2013-44, THE EMPLOYEE HANDBOOK,
REGARDING OVERTIME PAY ELIGIBILITY FOR POLICE OFFICERS ASSIGNED
TO THE HIGH INTENSITY DRUG TRAFFICKING AREA (H.I.D.T.A.)**

WHEREAS, the City of Hobart adopted an Employee Handbook as Ordinance 2013-44 on December 18, 2013; and

WHEREAS, the Employee Handbook establishes the policies and conditions of employment for City of Hobart employees; and

WHEREAS, the City of Hobart Common Council desires to amend said Employee Handbook to modify the overtime pay eligibility for Police Officers assigned to the High Intensity Drug Trafficking Area (H.I.D.T.A.) to provide consistency with other counterparts assigned to the H.I.D.T.A. from other local agencies;

THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF HOBART, LAKE COUNTY, INDIANA:


SECTION ONE: The City of Hobart Employee Handbook adopted by Ordinance No. 2013-44 is amended by striking out the last of Section 2 entitled "Expectations & Policies: Police Officers" in its entirety, and inserting in lieu thereof the following:

Officers shall be compensated for the actual time of Court appearances and call outs while off duty, but shall receive not less than two hours compensation for each call out or appearance. Officers assigned to the High Intensity Drug Trafficking Area (H.I.D.T.A.) will receive overtime at the rate of one and one-half regular time whenever overtime occurs irrespective of the officer's normal schedule of work. All of such overtime shall be compensated through H.I.D.T.A.

SECTION TWO: This Ordinance shall be in full force and effect after its passage by the Common Council and approval by the Mayor.

SECTION THREE: All other provisions of Ordinance 2013-44 shall remain in full force and effect.






