4 **An Ordinance to Amend the Hobart Municipal Code to Provide for the**
5 **Adoption by Reference of the Indiana Fire Code**

7 WHEREAS, the Common Council (“Council”) of the City of Hobart, Indiana (“City”) has been requested by the Fire Department, in consultation with the City Building Department, to adopt by reference and make effective the latest enactment of the Indiana Fire Code in the City as adopted by the Indiana State Fire Prevention and Building Safety Commission; and

12 WHEREAS, the adoption of said code for application in the City to buildings which are not otherwise subject to Indiana State Fire Marshall and other state inspections will enhance the safety of City residents and other members of the public; and

16 WHEREAS, the Council, through this Ordinance, desires to amend the City of Hobart Municipal Code to make such adoption effective.

19 THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart as follows:

22 *SECTION ONE.* The Municipal Code of the City of Hobart (“Code”), in Chapter 150 on “BUILDING REGULATIONS; CONSTRUCTION,” in the sub-chapter entitled “*BUILDING CODE ADOPTION*,” hereby amends Section 150.059 entitled “RULES ADOPTED BY REFERENCE” by adding a new paragraph to be designated paragraph (8) to sub-section (A) of that Section, to read as follows:

28 (8) Indiana Fire Code (675 I.A.C. 22-2.5) including all later amendments thereto as the same are published in the Indiana Register or the Indiana Administrative Code with effective dates as fixed therein, but also including the following Appendices to the International Fire Code, 2012 Edition, first printing dated May 2011, as published by the International Code Council, Inc., 4051 West Flossmoor Road, Country Club Hills, IL 60478-5795:




