ORDINANCE NO. 2017- 5

An Ordinance to Repeal Ordinance No. 2009-15 Enabling the Establishment of the City of Hobart 61<sup>st</sup> Avenue Governing Commission

WHEREAS, the Common Council ("Council") of the City of Hobart, Indiana ("City") previously enacted its Ordinance No. 2009- 15 which enabled the establishment of the 61st Avenue Joint Governing Commission ("Joint Commission") and approved the interlocal agreement between the City Board of Public Works and Safety and the Redevelopment Commission prescribing the rules of operation of said Joint Commission, said Agreement being incorporated into said Ordinance by reference; and

WHEREAS, the Joint Commission, by motion adopted at its duly-noticed public meeting of March 13, 2017, reported that its duties have been substantially performed and requested the Council to dissolve the Joint Commission; and

WHEREAS, said prior Ordinance adopted Section 2 (iii) of the said Interlocal Agreement which provides that the Joint Commission is dissolved and terminated by the Council as follows: "Ninety (90) days after the repeal of the enabling ordinance referred to in sub-section (c) of this section by the Council;" and

WHEREAS, the Council, further observing the impending completion of the third and final phase of the 61<sup>st</sup> Avenue improvement project supervised by the Joint Commission desires to carry out the request of the Joint Commission to implement its dissolution.

THEREFORE, BE IT ORDAINED by the COMMON COUNCIL of the CITY OF HOBART as follows:

SECTION ONE. Ordinance Number 2009- 15, which enabled the establishment of the 61<sup>st</sup> Avenue Joint Governing Commission, is hereby repealed.

SECTION TWO. The Council thanks and congratulates the members of the Joint Commission, both current and past, for their important contribution to the successful completion of the 61<sup>st</sup> Avenue Improvement Project, Phase Three.
