

ORDINANCE 2017-30

AN ORDINANCE AMENDING ORDINANCE 2017-13 OF THE CITY OF HOBART, LAKE COUNTY, INDIANA TO CHANGE SOME SALARIED POSITIONS TO HOURLY PAY POSITIONS FOR CERTAIN JOB CLASSIFICATIONS IN THE PARK AND RECREATION DEPARTMENT FOR THE FISCAL YEAR 2018

WHEREAS, the Common Council of the City of Hobart, Lake County, Indiana, adopted Ordinance 2017-13 on September 6, 2017, fixing the salaries of officers and employees of the City of Hobart for Fiscal Year 2018; and

WHEREAS, the Park & Recreation Board of Commissioners has recommended to the Council that the Park Department salaried positions of Secretary and Recreation Coordinator be converted to an hourly paid position for the fiscal year 2018; and

WHEREAS, the Common Council now desires to amend said Ordinance to convert the salaried positions of Park Secretary and Park Recreation Coordinator to hourly paid positions for the fiscal year 2018 as recommended by the Park & Recreation Board of Commissioners;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart, Lake County, Indiana as follows:

SECTION 1. That Ordinance 2017-13 be amended to convert the following Park Department salaried positions to hourly paid positions as follows:

SECTION 2. That the provisions of this Ordinance shall take effect January 1, 2018 as will all other provisions of Ordinance 2017-13 previously adopted.
