

**ORDINANCE 2019 - 42**

**AN ORDINANCE AMENDING ORDINANCE 2019-20 OF THE COMMON COUNCIL OF THE CITY OF HOBART, LAKE COUNTY, INDIANA, TO ESTABLISH NEW POSITIONS IN VARIOUS FUNDS AND FIXING THE SALARIES FOR SUCH POSITIONS FOR THE FISCAL YEAR COMMENCING JANUARY 1, 2020 AND ENDING DECEMBER 31, 2020, and TO AMEND ORDINANCE 2019-24, APPROPRIATIONS WITHIN THE 2020 BUDGET, TRANSFERRING OF APPROPRIATIONS IN CERTAIN FUNDS TO ALLOW FOR THE ESTABLISHMENT OF THE NEW POSITIONS IN 2020.**

WHEREAS, the Common Council of the City of Hobart, Lake County, Indiana adopted Ordinance 2019-20 on September 4, 2019, fixing the salaries of officers and employees of the City of Hobart for Fiscal Year 2020 and Ordinance 2019-24 Appropriations and Tax Rates/The 2020 Budget on October 16, 2019; and

WHEREAS, it is now the desire of the Mayor to create a position for the City Attorney to be a full-time city employee as a Department Head of the Legal Department in 2020, together with clerical help, rather than as a contractual employee as had been the practice in the past, to provide day-to-day services as needed to all departments of the City; and

WHEREAS, the Hobart Sanitary/Stormwater District Board and the Hobart Park Board have both expressed support and agreed to the shifting of appropriated funds in the 2020 budgets of their respective departments to facilitate the hiring of a City Attorney as a full-time employee; and

WHEREAS, the newly created positions would result in only the transfer of appropriated funds from certain established line items to the proposed new positions without the need for additional appropriations within the 2020 budget; and

WHEREAS, the Common Council now desires to amend said Ordinance 2019-20 to create two new positions and set a salary range for such positions as recommended by the Mayor and to amend Ordinance 2019-24, transferring appropriations within the 2020 Budget;

**NOW THEREFORE, BE IT ORDAINED** by the Common Council of the City of Hobart, Lake County, Indiana as follows:

SECTION ONE: That Ordinance 2019-20 be amended to include the following budget items and salaries in the 2020 budgets of the funds indicated:



 140 Council and approval by the Mayor and be reflected in the 2020 Budget of the City of Hobart.


142 SECTION FOUR: All other provisions of Ordinance 2019-20 and 2019-24 shall remain in full force and




