

ORDINANCE 2020 - 08

AN ORDINANCE TRANSFERRING APPROPRIATIONS WITHIN THE 2020 BUDGET OF THE GENERAL FUND: POLICE DEPARTMENT and the LAW ENFORCEMENT TRAINING FUND IN THE CITY OF HOBART, LAKE COUNTY, INDIANA.

WHEREAS, it has been determined it is now necessary to appropriate more money than was appropriated in the annual budget in certain line items in the General Fund: Police Department in the 2020 budget; and

WHEREAS, it has been shown that certain existing appropriations now have unobligated balances that are not currently needed and eligible for use to cover certain expenses for the purposes for which appropriated in the Law Enforcement Training Fund in the 2020 budget,

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart, Lake County Indiana that:

Section 1(a). For the expenses of the taxing unit, the following additional sums of money are hereby appropriated out of the General Fund: Police Department for the purposes specified, subject to the laws governing the same:
