

COMMON COUNCIL OF THE CITY OF HOBART, INDIANA

ORDINANCE NO. 2021 - 45
An Ordinance Amending the Fees and Charges for
Park Department Programs and Activities

WHEREAS, the Common Council ("Council") of the City of Hobart ("City") has been advised that some of the fees and charges previously established by the Park and Recreation Department ("Department") of the City are no longer sufficient to defray the actual costs of administering the various programs and administrative activities related to them; and

WHEREAS, the Board of Park Commissioners have considered a modification of Park Department Fees beginning in the fiscal year 2022 sufficient to support the operational and administrative activities measured by their true cost of operating the Department and hereby recommends same to the Council; and

WHEREAS, the Council has received and considered said recommendation and now desires to make its determination of new fees effective and to spread same upon the public record through this Ordinance.

THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart, Indiana as follows:

SECTION ONE. The Fee Schedule for the City of Hobart, 2022, is hereby amended as to Park Department Fees as follows:




