### AGREEMENT OF COURT REPRESENTATION

Comes now the undersigned Defendant and having requested the Court to appoint a Public Defender, and being duly sworn, now agrees to the following terms and conditions in the appointment of this Public Defender:

1. That subject to the penalties of perjury, the undersigned Defendant has divulged to the Court, under oath, all information with regard to income, employment and assets.

2. That as a condition of this appointment by the Court of a Public Defender for the undersigned's benefit, the undersigned Defendant agrees to notify the Court of any change in circumstances of employment, address, income or asset situation and shall be responsible for personally reporting to the Court within seven (7) days any change of circumstances.

3. That the undersigned further agrees that any such information with regard to employment, address, income, or assets which comes to the knowledge of the Public Defender should also be immediately brought to the attention of the Court by the attorney upon receiving this information.

4. Defendant acknowledges that, to the extent authorized by law, bonds posted may be applied to publicly paid cost of his representation, if he is found guilty.

5. That Defendant agrees to appear in Court at any time with forty-eight (48) hours notice to answer regarding Defendant's financial situation and failure to do so, the giving of false information, or failure to abide by this agreement may be considered a contempt of court which may subject the Defendant to incarceration not to exceed ninety (90) days.
