**Call to Order:** Mr. Lamprecht called the meeting to order at 6:00 p.m., followed by the Pledge of Allegiance.

**Roll Call:** The following members were present: Mr. Finnerty, and Mr. Lamprecht. Also present: Secretary Cheryl Govert, Attorney Mindel, Chief Smith and members of Local 1641. Absent: Mr. Schallenkamp

**Approval of the Agenda:** Motion by Mr. Lamprecht, seconded by Mr. Finnerty, to approve the agenda as presented. All aye, motion carried. (2-0)

**Approval of Minutes:** Motion by Mr. Lamprecht, seconded by Mr. Finnerty, to accept the minutes of the Regular Meeting of December 10, 2019 as presented. All aye, motion carried. (2-0)

**New Business:**


**Notice of Extension of Probation:** Fire Chief Smith provided a Memorandum of Probationary Extension for a new firefighter, which was read into the record. Motion by Mr. Lamprecht, seconded by Mr. Finnerty, to accept the Memorandum and to extend the probationary period as recommended by the Fire Chief. All aye, motion carried. (2-0)

**Request for Promotion Testing: Fire Prevention Director and Fire Marshall Positions:** Mr. Lamprecht said that the promotion lists for EMS Director and Fire Marshall have been exhausted. He has checked with Mr. Jaracz and he is available to proctor the test on April 18, 2020 at 9:00 a.m. Motion by Mr. Lamprecht, seconded by Mr. Finnerty, to move forward with promotion testing for EMS Director and Fire Marshall. The test will be scheduled for April 18, 2020 in Fire House #1 at 9:00 a.m. Mr. Lamprecht will post notices in all Fire Houses. All aye, motion carried. (2-0) The promotion test for Captain will take place in June or July 2020.

Chief Smith noted that there are 6 openings in the Department, and we may have to do a round of lateral transfer or new hire advertising/testing soon.
